NOTICE IS HEREBY GIVEN that bids will be received by the McDonald County Commission for the **Total Bridge Replacement** located at Hagee Rd. The project scope includes, but is not limited to, all materials, labor, excavation, bridge construction, and guardrail installation.

Project Scope

The successful bidder will be required to provide all labor, materials, equipment, and supervision necessary to complete the bridge replacement project. This includes, but is not limited to:

- **Demolition and Removal** of existing wood.
- **Excavation** and site preparation.
- **Installation of concrete foundation** and structural elements.
- **Bridge deck construction** (using concrete and/or asphalt).
- **Guardrail installation.**
- Compliance with all **Missouri Statutes**, including prevailing wage laws, **Missouri Revised Statutes Chapter 34**, and relevant **MoDOT specifications.**

Bid Requirements

- All bids must include a complete, detailed cost breakdown, including:
 - **Material costs** (concrete, steel, guardrails, etc.).
 - **Labor costs** (per classification of laborer).
 - **Excavation costs** (including machinery and disposal).
 - **Guardrail costs** (materials and installation).
 - **Contingency costs** (if applicable).
 - **Total project cost.**

- **Timeline:** The total duration of the project must be clearly outlined. The work must be completed within 60 days from start date.
- **Payment Terms:** Bidders should provide proposed payment terms, including progress payments and final payment upon project completion.
- **Compliance:** Bidders must comply with all state and local laws, including:
 - **Missouri Prevailing Wage Laws** (Section 290.210, RSMo).
 - **Missouri Department of Transportation (MoDOT) standards.**
 - **Affidavit of Work Authorization** (E-Verify compliance).
 - **Equal Employment Opportunity** requirements.

Eligibility

- All contractors must be licensed to perform work in the State of Missouri and must be in good standing with the Missouri Secretary of State and the Missouri Department of Revenue.

- **Submission Deadline:** All bids must be received no later than 1:00pm **February 5, 2025.**

Bids will be publicly opened and read aloud at **1:00pm** on **February 5, 2025**, at the County Commission Office located at 502 Main St. Pineville, Missouri. Interested parties are invited to attend the opening.

Bidder's Qualifications

All bidders are required to submit proof of qualifications and experience in the field of bridge construction, including detailed work history, contractor's license, bonding capacity, and proof of insurance.
