If this proposition is approved, the debt service levy of the school district is estimated to remain unchanged at \$0.8300 per \$100 of assessed valuation.</p> | <p>City of Anderson Question Shall the City of Anderson continue for another five (5) years a temporary property tax which will then expire unless renewed by a vote of the citizens? This property tax, which is approximately 30 to 35 cents per hundred dollars assessed valuation and set by the office of the State Auditor each year; poses no increase in taxes from the previous five years and the revenue from this is used for the general municipal purposes, including the summer ball program for community children.</p> |
