MCDONALD COUNTY 2021 BUDGET AMENDMENT MESSAGE

Now on this 15th day of December, 2021, comes Kimberly Bell, Clerk of the County Commission, as budget officer and presents for the records of the County Commission, information and estimates for the year 2021 as required by The County Budget Law (Sections 50.525 to 50.745, RSMo.) being in words and figures as follows:

BUDGET MESSAGE:

McDonald County received American Rescue Plan Act (ARPA) funds in the amount of \$2,217,910 in June 2021. These funds were passed down to counties directly from the U.S. Treasury and came with very muddy guidance. One thing was certain, lessons learned from 2020 made it necessary for the county to look at how to increase the capabilities of the McDonald County Health Department in protecting the health and safety of our citizens. The Commission decided to use the rest of the CARES fund and some of the ARPA funds to purchase land for a new health department facility and the U.S. Bank building on the Pineville Square to house three county offices. The bank building has become Annex 2 and will hold the Assessor's office, Collector's office and the Public Administrator's office. This renovation will provide greater social distancing between county employees, greater distancing between employees and the public; as well as, allow social distancing in the Courthouse during jury selection and court proceedings. These funds were also used on payroll for Health Department, Custodial staff, and Sheriff/Jail/Bailiff employees.

Amended in the 2021 Budget was the Schedule of Expenditures of Federal Funds (SEFA) to correct finding from the financial audit performed during 2021. Funds amended are as follows:

GENERAL REVENUE FUND – Estimated revenues increased a little over \$200,000 from originally estimated revenues. This included unanticipated donations for a new rescue boat, motor and trailer for Emergency Management department. Other revenues were underestimated. Estimated expenditures were amended to correct Insurance and Property liability, which was mistakenly estimated much lower than actual; Emergency Management rescue boat cost was added to expenditures; and Legal Services were increased to account for unanticipated Drug Court treatment Coordinator salary (reimbursed through State of Missouri) and to conduct a study of the I-49 corridor for potential business growth in McDonald County.

LAW ENFORCEMENT FUND – Estimated expenditures for Workers Comp was mis-keyed. \$3,000 was typed but it should have been \$30,000. Law Enforcement property and liability insurance was also estimated low at the beginning of 2021. Estimated Sales Tax Revenue and Reimbursement Incarceration revenue were amended to show a more accurate estimate and cover the increased expenditures.

CARES FUND – There were a lot of unknowns about CARES fund at the beginning of 2021. This fund has been amended to show the interest earned during 2021 that was not originally estimated. Also amended, were the expenditures to better represent how the remaining money was spent. CARES Fund was zeroed out prior to mid-year 2021.

ARPA FUND – American Rescue Plan Act fund was created in 2021 to account for federal award money received from the U.S. Treasury.

MCDONALD COUNTY 2021 BUDGET AMENDMENT MESSAGE

Below is a summarization of the amended estimated revenues and expenditures in 2021 for each department amended:

- General Revenue began the year with a balance of \$440,001.56. Revenues expected of \$2,046,957.51 and expenditures of \$2,312,401.00, with an ending balance of \$172,558.07.
- Law Enforcement started the year with a balance of \$158,328.89. Revenues expected of \$2,132,500.00 and expenditures of \$2,166,523.00, with an ending balance of \$124,305.89.
- CARES fund began the year with a balance of \$315,923.45. Revenues estimated for interest received is \$4,123.00 and expenditures of \$320,046.45. Ending balance for this fund will be \$0.00.
- ARPA fund was created during 2021. Beginning balance was \$0.00. Revenues expected of \$2,217,910.00 and expenditures of \$1,528,000.00, with an ending balance of \$689,910.00.

It is with a servant heart, I faithfully submit this budget to the McDonald County Commission. May God bless McDonald County.
