

Chief Justice Brent Powell, has directed that judicial offices will be closed on the following state holidays:

Lincoln's Birthday	Thursday	February 12, 2026
Washington's Birthday	Monday	February 16, 2026
Truman Day	Friday	May 8, 2026

Juneteenth	Friday	June 19, 2026
Independence Day	Friday	July 3, 2026
Labor Day	Monday	September 7, 2026
Columbus Day	Monday	October 12, 2026

Christmas Day	Friday	December 25, 2026

When it is impracticable to give time off to an employee regularly scheduled to work on any of the above holidays in order to continue essential services, the appointing authority shall allow the employee to record the hours worked as compensatory time. The appointing authority shall allow the employee to take appropriate compensatory time off at such time or times as the appointing authority shall designate. The preceding does not apply to employees who by virtue of their management position, are not authorized to accrue compensatory time.
