## **General Business**

Commission met with Sam Thao regarding the condition of Low Gap. After a discussion, Commissioner Bunch made a motion to put Low gap on the road maintenance schedule for two gradings per year.

Leslie Smith met with the Commission and Assessor, Laura Pope. Mr. Smith's issue was resolved and he no longer wishes to meet at the Board of Equalization meeting.

Commissioner Bunch made a motion to enter into Board of Equalization. Commissioner Lindquist second. Vote was unanimous. Board of Equalization meeting was brought to order with Commissioner Lindquist opening the meeting.
